Steelcase Director of Design featured in February

Bruce Smith — *The Art of Industry* – February 11, 10am



Bruce Smith is Director of Design for Steelcase Inc., the global leader in the office furniture industry. Appointed to his present position in 1999, Bruce is responsible for directing the design of Steelcase's global seating products and global surface materials portfolio. Earlier assignments include manager of design for systems furniture and senior industrial

designer for the firm. Prior to joining Steelcase in 1986, Bruce worked at Gates Lear Jet Corporation in Tucson, Ariz., from 1978 to 1986 as a senior industrial designer. His work included designing private jet interiors for custom orders, cabinets, seating, exterior graphics and corporate graphics design.

He will join us in February to discuss the art of industrial design and the process of designing in response to human need. As always, you are invited to continue the conversation with the speaker during the coffee reception following the program.

Ad-hoc Steering Committee



March Program

Artists Share Insights Sharon Sandberg & Don Kerr *Japanese Art: The After Images* March 11, 10am

Don Kerr and Sharon Sandberg will speak about their four semester residencies as Visiting Scholars at the Japan Center for Michigan Universities in Hikone. The core subject of their teaching has been Art and Japanese Culture during these sojourns.

They will elaborate on the influence it has had on their lives, appreciation of non-Western Art and Culture, and, in the case of Sandberg, to what extent it has had a tangible impact on her artistic vision and painting imagery.



Sharon Sandberg is an award-winning artist and an educator, currently serving as Director of Painting at Aquinas College. In addition to his time in Japan, Don Kerr is a Professor Emeritus and Artist in Residence of Grand Valley State University and an adjunct professor at Aquinas College.



Art League Honored to Receive Community Foundation Grant

Legal requirements change, "best practice" evolves, but one thing doesn't change in Art League: we continue to strive for excellence. To that end, break-out groups and big post it notes have become a feature of recent Board meetings as we affirm our mission and begin to look at strategies that will take us into the future.

As we read our history, listen to our fellow members, and celebrate 60 years of service, it's a good time to reflect on where we've been and where we are going. With best wishes from KIA senior staff and the support of our Board, last fall Art League prepared and submitted an

application to the Kalamazoo Community Foundation for a "capacity building" grant. In December we were notified that the "grant request to support Board Development and Bylaws had been approved in full for \$2400."

What does that mean for Art League? It means an expert in non-profit management will help us align our policies with changes in law, will advise us of best practice, and will help us determine if our Bylaws are consistent with our current goals as well as our legal responsibilities. It means it's important to "get it right" and the Foundation has faith that with a little help, we'll do just that.



Spring depARTures



South Bend Museum Tours and a Twilight Party Thursday, April 16

Once the Saint Patrick's Day craze and the Easter solemnities are over at Notre Dame, our first 2015 Art League depARTure will leave Kalamazoo for South Bend in a luxury motor coach on the morning of April 16th.

Our first destination will be the Oliver mansion, an imposing 38-room Romanesque Queen Anne house built in 1895-1896. It's a time capsule of "Gilded Age" decorative arts. Following our visit to the Oliver mansion, we'll enjoy an elegant luncheon in an equally lovely setting, the famous Tippecanoe Place Restaurant in the old [original] Studebaker family mansion.

After lunch we will be welcomed to the South Bend Museum of Art with galleries featuring Indiana-born artists of note from William Merritt Chase to Robert Indiana. Other famed artists exhibited represent the Hoosier Group, the Ashcan group, and contemporary Chicago Imagists.

Next we will drive to the University of Notre Dame Snite Museum of Art. There we'll be given a special Curators' Favorites tour led by the museum's curators. The Snite's extensive collections range from Old Masters paintings to a vast collection of Mesoamerican and Northern Native American art.



As April 16 is special at the Snite, you have been invited to "3rd Thursdays @ The Snite: Figure It Out" which begins at 5 p.m. You'll be offered a complimentary glass of wine, and a chance to browse through open galleries where along the way you may discover working artists and their live nude models.

Before heading home to Kalamazoo, we'll take time to savor the day's experiences together, enjoying the classic Tuscan fare at Carmela's.
